

# **NOW90 – The Climb**

## ***Official Promotion Policies & Procedures***

### **1. Purpose**

NOW90 – The Climb ("Promotion") is a 90-day performance-based incentive program designed to reward measurable net volume growth within the HealthyHome binary structure.

### **2. Promotion Period**

The Promotion begins March 1, 2026 and concludes at the close of the commission week ending May 31, 2026. All qualification measurements are based on official HealthyHome commission reporting.

### **3. Eligibility**

Open to all active Executive Members and above in good standing. Participants must register and remain compliant throughout the Promotion period.

### **4. Baseline Determination**

Baseline volume is established from the commission week ending March 1, 2026, reflecting total QV on both left and right legs. Growth targets are measured as net positive growth above this locked baseline.

### **5. Volume Measurement Standard**

Volume is measured as net growth above baseline. Qualification is determined by verified growth milestones at each Camp close.

### **6. Camp Milestones**

Each Camp has a defined growth target above baseline that must be achieved on both legs to earn that Camp bonus. Failure to meet one Camp does not remove participation in future Camps.

## **7. Final 90-Day Requirement**

Participants must achieve +7,500 QV per leg above baseline by Day 90 to complete The Climb and qualify for final recognition or bonus.

## **8. Enrollment Requirements (Elite and Above)**

Elite through Crown Diamond ranks must personally enroll four new Executive Members during the Promotion, placing at least one on the left leg and three on the right leg. Each must activate a subscription that processes at least once.

## **9. Refunds, Returns & Adjustments**

Refunded, returned, or canceled orders may reduce qualifying volume. HealthyHome reserves the right to revise payouts accordingly.

## **10. Compliance & Anti-Manipulation**

Volume stacking, account manipulation, fake accounts, structural adjustments for qualification, and other non-compliant behaviors are strictly prohibited. HealthyHome may audit, disqualify, withhold bonuses, or terminate accounts at its discretion.

## **11. Audit & Verification**

All payouts are subject to compliance review and back-office reconciliation. Corporate approval is required before bonus release.

## **12. Dispute Resolution**

Official HealthyHome reporting supersedes personal tracking. Disputes must be submitted within 7 days of Camp close. Corporate determination is final.

## **13. Payment Schedule**

Qualified bonuses will be posted on the commission adjustment line for the week ending June 21, 2026 following final audit.

## **14. Modification & Termination**

HealthyHome reserves the right to modify, clarify, or cancel the Promotion due to regulatory changes, fraud concerns, system errors, or business necessity.
